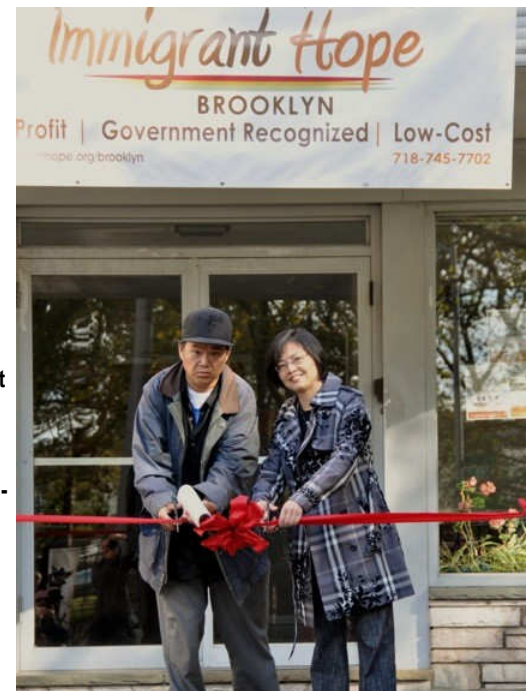

Michelle Adams - Volunteer Pro-Bono Attorney

Michelle A. Adams is a pro-bono attorney with Immigrant Hope. She enjoys participating in the ministry center one day a week to see clients, research cases, and discuss them with the supervising attorney.

Raised in Michigan, Michelle was blessed to grow up in a strong Christian family and attend a very missions-minded church. After attending Cedarville College, she was able to find a crossing between her natural love for studying the law and participation in evangelical missions. Since graduating from Regent University School of Law, Michelle has maintained a solo practice specializing in nonprofit/tax exempt issues for Christian evangelical ministries. She has been able to maintain her goal of providing affordable fees for these special organizations by working out of her home and keeping interactions as paperless as possible.

Even though she considers her daily office tasks to be Kingdom work, Michelle feels it is important for every Christian to be involved in some kind of one-on-one ministry. It is good to support ministries financially or through background efforts (such as the practice of law), but unless that Christian is able to look into a neighbor's face, witnessing God's love for them in both word and deed, he or she will miss out on the great privilege and plan that God has laid out for His followers.

Also important to Michelle is her volunteer work at the Brooklyn Arab American Friendship Center down the avenue from Immigrant Hope. This is an amazing and unique opportunity to pour Christ's

Michelle is grateful to have learned about the work of Immigrant Hope just as it was getting started, since she had long envisioned branching her practice into immigration law for the purpose of sharing the Gospel through this tangible service. She believes this is one of the most effective yet neglected avenues to reach internationals for Christ.

Immigrant Hope - Brooklyn Advocates in Problematic Consulate Case

Immigrant Hope - Brooklyn successfully completed the first major advocacy case for a client who is in fact the first one whom we helped to pray to receive Christ. The client had petitioned for legal residency for a relative family of five from overseas. However, only the parents and two of their children were issued the immigrant visas from the U.S. consulate and their oldest daughter (the client's niece) was left behind unjustly. The immigrant visa case of our client's niece hit a problem at the consulate level because of two unfortunate mishaps: our client had hired an unauthorized practitioner to handle her case and there were probable corruption activities in the home country of her relative family. Through intense advocacy efforts and with the help of a local senator, Martin Golden, we were able to re-open the case with the U.S. consulate and ask for an immigrant visa interview. Finally, an immigrant visa has been granted to the niece, and now she will soon arrive in the U.S. as a legal resident and be united with her family after more than two years of separation! As the relational bridges have been built up, we hope to be able to share the saving grace of Christ to her and her family at her arrival.

Client Stories

Immigrant Hope - Brooklyn serves a diversity of clientele. We not only help them with their immigration needs but we are sometimes able to share the gospel with many of our clients.

- A homeless person came to us for help last year. We were able to pray with him to receive Christ. We first met his felt immigration need, helped recover his identity documents, then connected him to a Christian program that provides meals to him during the day. As our caseworkers developed the relationship with him, they were able to invite him to make a commitment to Christ.
- Through the recent Deferred Action program we provided services to a number of young people. In many instances we were able to give out Bibles and tracts and openly share the gospel with them. **Please pray** that our caseworkers will be able to follow up on these relational bridges that have been built.
